Is supposed to be in the state of Georgia or in the upper part of South Carolina, where he was purchased, having formerly been the property of judge Johnston. A reward of Forty Dollars and all reasonable expenses will be given to any person who will deliver him at Mr. George M. Gibbes' plantation, on Combahee; or at the gaol in Charleston.
